Notes to Table of Rates:

1. The Acreage Dedication Rate is available to any shipper that has entered into and has an effective acreage dedication agreement with Carrier related to gathering service on the Outrigger Gathering System, pursuant to which the shipper has dedicated for shipment on Carrier's system all of the Crude Petroleum produced from a specified area within Campbell County, WY.
2. A list of the receipt points within "Outrigger GS Zone 1," "Outrigger GS Zone 2," and "Outrigger GS Zone 3" is available on Carrier's public website at www.scmidstream.com.
3. Additional charges and fees shall apply for transportation on the PRCS Mainline, as set forth in Carrier's F.E.R.C. No. 1.13.0 or subsequent reissues thereof.
4. The DSU Dedication Rate is available to any shipper that has entered into and has an effective dedication agreement with Carrier, pursuant to which shipper has dedicated for shipment on Carrier's system all of the Crude Petroleum produced from certain specified drilling spacing units (or DSUs) within Campbell County, WY.
5. Except as stated in a TSA, any shipper that ships under this tariff shall be subject to a pipeline loss allowance of 0.15%.
6. To the extent Carrier receives a request for walk-up service on the Outrigger Gathering System under this tariff, Carrier will amend this tariff to post a walk-up rate.
