- The referenced Acreage Dedication Rate is available to any shipper that has entered into and has an effective
  acreage dedication agreement with Carrier, pursuant to which the shipper has dedicated for shipment on
  Carrier's system all of the Crude Petroleum produced from the specified dedication area located within
  referenced Zone.
- 3. The referenced Acreage Dedication Rate is available to any shipper that has entered into and has an effective acreage dedication agreement with Carrier, pursuant to which the shipper has dedicated for shipment on Carrier's system all of the Crude Petroleum produced from at least 95,000 acres.
- 4. Additional charges and fees shall apply for transportation on the PRCS Mainline, as set forth in Carrier's F.E.R.C. No. [W] 1.14.0 1.13.0 or subsequent reissues thereof.
- 5. Pursuant to the terms of the TSA, any shipper that qualifies for the Acreage Dedication Rate applicable to movements from the Pronghorn North GS Zone 1 shall qualify for the following incentive rates: (1) if shipper ships, on average, an aggregate of at least 20,000 barrels per day during the immediately prior three month period, such shipper shall qualify for a Tier 1 incentive rate of [D] 36.15 cents per barrel for movements in the current month and (2) if shipper ships, on average, an aggregate of 50,000 barrels per day or greater during the immediately prior three month period, such shipper shall qualify for a Tier 2 incentive rate of [D] 25.41 cents per barrel for movements in the current month. For clarity, the Tier 1 and Tier 2 incentive rates shall

- only be accessed for movements from the Pronghorn North GS Zone 1 but any movements made by shipper on the Pronghorn North Gathering System shall be considered in determining whether shipper meets the requisite volume thresholds to qualify for the Tier 1 and Tier 2 incentive rates.
- 6. Except as stated in a TSA, any shipper that ships under this tariff shall be subject to a pipeline loss allowance of 0.15%.
- 7. To the extent Carrier receives a request for walk-up service on the Pronghorn North Gathering System under this tariff, Carrier will amend this tariff to post a walk-up rate.
